  - ii Applicants for a first year Grant <u>must</u> be accompanied by <u>unconditional</u> acceptance of the Applicant by the appropriate University or College, or Vocational Training Establishment
  - iii Applicants in respect of 2<sup>nd</sup> and 3<sup>rd</sup> year students <u>must</u> be <u>accompanied</u> by evidence of Applicant's continuation of the course
- B. "Higher Education" means post "A" level Courses.
- C. "Vocational Training" means a Level 2 Level 6 course leading to an employment qualification
- D. Book Grants given are generally, £350 Book Tokens for the first year of the Course and on re-application with evidence of continuation of that course, a £300 Book Token for the second and for the third year.
- E. Vocational Grants given are generally £350 payable to the applicant in the first year of the Course and on re-application with evidence of continuation of that course £300 payable similarly for the second year and for the third year.
